1. Memory of Utopia: Retrieving the History of Destruction of the Past.

This project is led by Bronwen Neil and Pauline Allen at the Australian Catholic University. The project summary Christianity and paganism contested claims to utopia. This conflict was carried out on various levels: the rhetorical, the material (destruction of temples), the epigraphic (inscriptions, graffiti) and artistic. Exclusive rhetoric of purity discourse can easily escalate into violence. The collaborators examine the available literary, archaeological and epigraphic sources from 300 to 600 CE, in order to build up an accurate and comprehensive picture of Roman practices of and responses to utopianism, both Christian and pagan. As a prelude to the later clash with Islam, it shows how socially marginalised groups constructed religious identities and defended them, often with violence. We also highlight the strategies – both rhetorical and political – that were used to reframe and erase history for utopian ends. This project examines the evidence for competing utopian ideologies. It highlights the focus on marginalising discourses among North African, Syrian and Egyptian pagans and Christians, whose religious and social groupings were particularly prone to violent factionalism.
